
### Ty Stokes, P.E.

Ty has experience leading the bridge design elements of transportation projects and has served as the structures task lead on owner's representative assignments. Ty received a Bachelor's degree in Engineering from the University of South Carolina and a Master's degree in Civil Engineering from the University of Illinois at Urbana-Champaign. Ty is a registered professional engineer in South Carolina.

### **Presentation Abstract**

The Greene Street Improvement project is a major step to connect downtown Columbia through University of South Carolina campus to the planned Congaree Waterfront Park as part of a sustainable waterfront live/work development area. This presentation will summarize the rich project history, complex stakeholder involvement, and Greene Street bridge design over CSX Transportation and Norfolk Southern railroads. The project was included in USC's master plan dating back to the 1990s and was driven forward by the forethought of community leaders and property owners. In 2014, HDR was engaged to perform the roadway and bridge design. The project entailed constant communication and negotiation with high-profile stakeholders, often with varying interests. To meet the vision for the project, the design required a unique stainlesssteel railing and additional aesthetic components.
